By creating an account or using Ratr, you agree to these Terms.

3. ELIGIBILITY

You must be at least 16 years old.

4. USER CONTENT

You remain solely responsible for content you publish.

You warrant that:

- you own or control the rights to uploaded content;

5. RATE-ME POSTS

Rate-Me content is limited to the user publishing the content.

Users may not:

- upload photos of other people for rating;
- upload videos of other people for rating;
- rate third parties.
